### A Checklist: Keeping you up-to-date on Hot Checks!

Dear Merchants,

In an effort to keep you informed, my office has prepared for you the "Monthly Hot Check" newsletter. Please use this information to guard against receiving bad checks in the future.

The Camp County Hot Check Department collected **\$4,891.96 in funds for bad checks for the month of December, 2009** and paid out \$2,930.83 in restitution and merchant's NSF fees, with the remaining \$1,961.13 to Camp County for court costs, fines and processing fees.

The yearly total collected for hot checks was \$79,456.96 and from that amount, \$41,564.88 of it was paid back to merchant's for their restitution and NSF fees.
