Dear Merchants,

In an effort to keep you informed, my office has prepared for you the "Monthly Hot Check" newsletter. Please use this information to guard against receiving bad checks in the future.

The Camp County Hot Check Department collected (with assistance from local law enforcement agencies) **\$12,348.46 in funds for bad checks for the month of February, 2010** and paid out \$6,708.11 in restitution and merchant's NSF fees, with the remaining \$5,640.35 to Camp County for court costs, fines and processing fees.
