OTHER FEES:

Expedited Foreclosure Citations

Each defendant/respondent/occupant must be served by the District Clerk by certified mail AND regular mail. However, only one citation issuance fee of \$8.00 AND one service fee of \$150.00 may be charged per defendant/respondent/occupant. Copies of the Petition/Application that attach to each citation are \$1 per page or may be provided by the Petitioner/Applicant's attorney.
